KNOW ALL MEN BY THESE PRESENTS

THIS DECLARATION is made on the date set forth below by BICKFORD DEVELOPMENT CORPORATION, a Texas corporation, hereinafter called "Declarant",

WITHESSETH:

WHEREAS, Declarant is the Owner of certain property in the County of Herris, State of Texas, which is more particularly described on the attached Exhibit "A", and

MHEREAS, by a Condominium Declaration, hereinsfter called "Declaration", executed on November 19, 1981, and recorded on November 24, 1981, in Volume 121, Page 1 of the Condominium Records of Marris County, Texas, the Declarant therein restricted WATERMAN CROSSING CONDONINIUNS, PHAGE 1, consisting of one hundred eight (108) Units, to Condominium ownership; and

WHEREAS, the above referenced Declaration provides in Paragraph 2.11 that the Declarant may annex additional property to WATERMAN CROSSING CONDONINIUMS, FRASE I, as defined therein; and

WHEREAS, the Declarant is desirous of annexing and merging the adjoining tract described as PHASE II in the Declaration on which exist minety-six (96) Units;

NON THEMEFORE, Declarant hereby declares that all of the Property described above as PHASE II in the Declaration shall be held, sold and conveyed subject to the essements, restrictions, covenants and conditions set forth in the Declaration for WATERMAN CROSSING COMDONINIERS, PHASE I, all of which are for the purpose of enhancing and protecting the value, desirability and attractiveness of the real property described above. The said ensements, restrictions, covenants and conditions shall run with the above described Property and shall be binding on all parties having or acquiring any right, title or interest in the said Property or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each Omer and Innsee thereof. The Property described in the Plat of MATERMAN CROSSING CONDUMINISHS, as PHASE 11, which Plat is attached hereto as Exhibit "B", shall become a part of the regime, as defined in the Declaration, and the ninety-six (96) Units shown on the Plat of PHASE 11, shall become Units, as defined in the Declaration, and from and after the filing hereof, WATERMAN CROSSING CONDUMINISHS, PHASE 11 shall be a part of the regime as if it had been originally described in the Declaration and the percentage or fraction of ownership interest in the Common Areas is hereby reallocated and established among the total of two bundred Hour (204) Units as set out in Exhibit "C", attached hereto.

This Supplemental Declaration of Merger and Annexation may be anumled by Declarant without joinder of any Unit Owner or Mortgagee in order to correct errors and discrepancies in said document or to comply with the requirements of the Veterans Administration, Federal Home Loan Mortgage Corporation, Federal Mational Mortgage Association or any other persannent lender approved by the Declarant; provided, however, that no vested property rights of any Sait Owner shall be materially affected.
