THIS DECLARATION is made on the date set forth below by BICKFORD DEVELOPMENT CORPORATION, a Texas corporation, bereinefter called "Declarant",

## WITHESSETH:

WHEREAS, Declarant is the Owner of certain property in the County of Harris, State of Taxas, which is more particularly described on the attached Exhibit "A", and

WHEREAS, by a Condominium Declaration, hereinafter called "Declaration", executed on Movember 19, 1981, and recorded on Movember 24, 1981, in Volume 121, Page 1 of the Condominium Records of Harris County, Texas, the Declarant therein restricted WATERMAN CROSSING COMPOSITIONS, PHASE I, consisting of one hundred eight (108) Units, to Condominium ownership; and

WHEREAS, by a Supplemental Declaration of Merger and Annexation, executed on July 7, 1982, and recorded on July 12, 1982, in Volume 125, Page 94, of the Condominium Records of Harris County, Texas, the Declarant therein restricted WATERMAN CROSSING COMBONINIUMS, PHASE II, consisting of ninety-six (96) Unita, to Condominium ownership; and

UNITERIAS, the above referenced Declaration provides in Paragraph 2.11 that the Declarant may annex additional property to WATERMAN CROSSING COMMUNITIES, PHASE I, as defined therein; and

WHEREAS, the Declarant is desirous of annexing and merging the adjoining tract described as PHASE III in the Declaration on which exist minsty-six (96) Units;

HOW THEREFORE, Declarant hereby declares that all of the Property described above as PHASE III in the Declaration shall be held, sold and conveyed subject to the easements, restrictions, covenants and conditions set forth in the Declaration for WATERMAN CROSSING CONDOMINIUMS, PHASE I, all of which are for the purpose of embancing and protecting the value, desirability

and attractiveness of the real property described above. The said easements, restrictions, covenants and conditions shall run with the above described Property and shall be binding on all parties having or acquiring any right, title or interest in the said Property or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each Owner and lessee thereof.

The Property described in the Plat of WATERMAN GROSSING COMPONISHING, as PHASE III, which Plat is attached hereto as Exhibit "B", shall become a part of the regime, as defined in the Declaration, and the ninety-six (96) Units shown on the Plat of PHASE III, shall become Units, as defined in the Declaration, and from and after the filing hereof, WATERMAN CROSSING COMPONISHING, PHASE III shall be a part of the regime as if it had been originally described in the Declaration and the percentage or fraction of ownership interest in the Common Areas is hereby reallocated and established among the total of three hundred (300) Units as set out in Exhibit "C", attached hereto.

This Supplemental Declaration of Merger and Annexation may be encoded by Declarant without joinder of any Unit Owner or Mortgages in order to correct errors and discrepancies in said document or to comply with the requirements of the Veterans Administration, Federal Home Loan Mortgage Corporation, Federal Mational Mortgage Association or any other permanent lender approved by the Declarant; provided, however, that no wested property rights of any Unit Owner shall be materially affected.
